# CONTRACTUAL APPOINTMENT OF PROGRAM MANAGER, AIR QUALITY EXPERT, TECHNICAL CONSULTANT, AND GIS ANALYST

Bihar State Pollution Control Board, Patna invites online applications for contractual appointment for the following posts for the establishment of a dedicated **Air Quality Management (AQM) Cell**. The engagement of personnel shall be purely contractual and will not guarantee any claim for employment or regularisation by this Board in the future. The details are as follows:-

### **HOW TO APPLY**

- a) The candidates willing to apply for the above posts shall fill up the online Application Form with required details & documents correctly. Candidates are advised to click the link: <a href="https://forestonline.bihar.gov.in/OnlinePCB/Home.aspx">https://forestonline.bihar.gov.in/OnlinePCB/Home.aspx</a> to read general instructions before filling application form, register and generate user ID and password.
- b) Registration is mandatory for e-filing of the form. Generate User Id and Password to login to fill the application form and finally submit through their user ID and Password.
- c) Verify your entries before submitting finally by clicking the final submission button. No modification can be made after final submission. Only finally submitted applications will be considered. Print a copy of finally submitted application form (for reference only).
- d) The applicant must upload a recent colour passport-size photograph, signature, and self-attested copies of all the mark sheets, certificates, and documents (including educational qualifications, experience certificates, ID proof, etc.).
- e) Applicants should ensure that the relevant details i.e. name, date of birth, etc. entered in the online application should be the same as mentioned in their official documents.
- f) Applications without supporting documents/incomplete/not fulfilling the prescribed criteria in any respect are liable to be rejected.
- g) The applicants are advised to submit the 'Online Application' well in advance without waiting for the last date of submission of the application.

## **GENERAL INSTRUCTIONS**

- i. By Premier University/ Institute, it refers to such institutions which, overall ranking, fall within the top 50 ranks in the latest ranking of the NIRF conducted by the Ministry of Human Resource Development, Government of India or the Recognized Foreign University fall within the latest top 50 rank in QS/THE.
- ii. This contractual appointment is for the Air Quality Management (AQM) Cell. The appointment shall be strictly on a contract basis for an initial period of Three Years, which may be renewed subsequently depending upon satisfactory performance and requirement.
- iii. Only Indian Nationals are eligible to apply.
- iv. The candidate must be in good physical and mental condition, bodily health and free from any physical disorder. A candidate, who after such medical examination is not found to satisfy these requirements shall not be appointed to the post.
- v. The candidate must be able to speak, read & write Hindi/English.
- vi. Only those applicants/candidates, who fulfil the requisite qualification and within the prescribed age limit will be considered eligible.
- vii. The certificate of 10<sup>th</sup> Class/Matriculation from Bihar School Examination Board or Equivalent Certificate from any other educational institution recognized by the Government of India/State Government will be acceptable for determination of age.
- viii. Before filling up the Online Application, the applicants must go through the detailed advertisement available on the Board's website. Please proceed to fill the online application only if you are satisfied that you possess the minimum Essential Qualifications stipulated for the post in the advertisement. Otherwise, submitted application (s) shall be out rightly rejected.

- The candidates should ensure that they fill up all the eligibility criteria and other conditions mentioned in this advertisement and that the particulars furnished by them in the online applications are correct in all respect. At any stage of the recruitment process, if it is found that the candidate has furnished false or incorrect information then the candidature/appointment of the candidate is liable to be cancelled.
  - x. The selected candidates shall have to enter into an agreement with the Bihar State Pollution Control Board (BSPCB) in the prescribed format, which will contain the terms and conditions.
  - xi. The e-mail Id entered in the online application form must remain valid for one year. All future communication with the candidates will take place through e-mail only. BSPCB will not be responsible for any loss/non-delivery of e-mail/any other communication sent, due to Invalid/wrong Id or due to any other reason.
  - The candidates are not required to send the printouts of their online applications to the Board. No manual/paper application will be entertained.
  - xiii. BSPCB reserves the right to change the minimum eligibility standards. The management reserves the right to fill or not to fill or partly fill any of the above posts/positions without assigning any reason whatsoever. BSPCB also reserves the right to cancel/restrict/modify/after the recruitment process, if need arises, without issuing any further notice or assigning any reason whatsoever.
  - xiv. Canvassing by a candidate in any form shall disqualify his/her candidature.
  - xv. The decision of Bihar State Pollution Control Board will be final & binding on all matters relating to eligibility, acceptance or rejection of application/candidature, selection of candidate, cancellation of the recruitment process, etc.
  - xvi. The candidate will receive all communication in the active Email ID provided by them.
  - xvii. Candidates are required to visit the BSPCB website- <u>bspcb.bihar.gov.in</u> at regular intervals for any notification, news or updates/latest updates relating to recruitment as no separate communication will be sent.
  - xviii. Applicants/Candidates working in any organization may submit their application online directly to the Board. Applicant applying for more than one post must apply separately.
  - xix. The service conditions shall be as decided by the Board.
