To strengthen the air quality management and compliance mechanism in the state, BSPCB is establishing a dedicated Air Quality Management (AQM) Cell. 4. Terms and Conditions of Service (Contractual)

- i. The contractual service will be for an initial period of 03 years on the basis of an agreement, which may be extended for one year at a time based on the requirement of the program, satisfactory performance and the requirement.
- ii. An annual increment of up to 10% in the monthly consolidated remuneration may be admissible upon completion of each year of service, subject to performance evaluation by the Board.
- iii. The monthly remuneration is a consolidated amount and includes EPF contributions/ deductions as applicable. No other payment will be made in addition to the prescribed remuneration.
- iv. Contractual employees will be admissible for Casual Leave (CL) and Public Holidays as per the Board's policy. No other leave will be admissible and for any absence beyond the said leave, pro-rata deduction will be made from the consolidated remuneration. No carry forward of the unconsumed leave as also no encashment of leave would be allowed
- v. For official duty tours, travel and daily allowances will be admissible as per the rules applicable in the Board.
- vi. This arrangement is purely contractual in nature, and will not form the basis for any regular appointment in the future.

The applicant must upload a recent colour passport-size photograph, signature, and self-attested copies of all the mark sheets, certificates, and documents from Higher Secondary School Certificate/ 10th Certificate onwards towards proof of qualification and experience, marks obtained, Photo ID, etc. as specified in the online application form.
- vi. Applicants should ensure that the relevant details i.e. name, date of birth, etc. entered in the online application should be the same as entered in their official documents. No hard copy applications shall be accepted.
- vii. Applications without supporting documents/incomplete/not fulfilling the prescribed criteria in any respect are liable to be rejected.
- viii. An applicant can apply for more than one post. However, a separate application must be submitted for each post.
- ix. The applicants are advised to submit the 'Online Application' well in advance without waiting for the last date of submission of the application.

6. Selection Procedure

The selection of candidates for all advertised posts will be conducted by a Selection Committee constituted by the Bihar State Pollution Control Board.

- All online applications received by the closing date will be scrutinized to determine eligibility based on the essential qualifications, age, and experience criteria mentioned in this advertisement.
- ii. Applications that are incomplete, do not meet the minimum eligibility criteria, or are not accompanied by the required documents will be summarily rejected.
- iii. The Board will prepare a list of all eligible candidates who will be considered for the next stage.
- iv. Based on the number of eligible applications received, the "Selection Committee" may decide to shortlist candidates for the interview.

- v. Only the shortlisted candidates will be called for a personal interview.
- vi. Candidates called for the interview must produce all original documents for verification, including educational certificates, mark sheets, experience certificates, Photo ID, and No Objection Certificate (NOC), as applicable.
- vii. Failure to produce the required original documents at the time of the interview will lead to the cancellation of candidature.
- viii. The Selection Committee will prepare a merit list of selected candidates. The competent Authority of the Board will issue appointment letters to the selected candidates from the merit list.

7. General Instructions, Essential Information and Clarifications:

- i. The candidates of only Indian Nationality can apply for these posts.
- ii. As the official work of the Bihar State Pollution Control Board is primarily conducted in Hindi, candidates are expected to have a working proficiency in the Hindi language (ability to read, write, and speak). This will be essential for official communication, file notings, and interaction with stakeholders.
- iii. The Candidates must carry the original photo ID proof which has been mentioned in the application, at the time of interview for verification.
- iv. There is No Application Fee for applying any of the post.
- v. Applicants must ensure before applying that they possess all essential qualifications and experience as on the cut-off date. Experience specified shall be the experience acquired after obtaining the essential educational qualifications. Applicants are advised to ensure before applying that they possess essential qualification and experience for the post. No updating of qualification and experience will be entertained after the last date.
- vi. Applicants shall upload the scanned copies of the certificates/ relevant documents with the application form. Further, all original documents must be produced at the time of document verification/ interview.
- vii. Application once submitted cannot be altered or resubmitted under any circumstances. Candidates are advised to fill the online application form within the last due date with utmost care.
- viii. The person applying for more than one post must apply separately.
- ix. Applicants currently serving in Government/ Semi-Government/ PSUs must obtain a No Objection Certificate (NOC) from their employer and produce it at the time of the interview, failing which their candidature may be cancelled.
- x. BSPCB shall verify the antecedents and documents submitted by applicants at any time, at the time of appointment or during the tenure of contract. In case, it is found that the Applicants have submitted fake documents or the applicants have undesirable clandestine antecedents/background and have suppressed the material information, his/her contract shall be liable to be terminated.
- xi. The character of a person for appointment must be such as to render him/her suitable in all respect for appointment to the above posts. Persons dismissed by the Union Government or by a State Government or by a Local Authority or a Government Corporation owned or controlled by the Central Government or State Government will be deemed to be ineligible for appointment.
- xii. Canvassing in any form will be a disqualification.

xiii. The Board reserves the right to:

- (a) Withdraw the advertisement either partly or wholly at any time without assigning any reason to this effect.
- (b) Fill or not to fill up some or all the posts advertised for any reasons whatsoever.
- (c) Increase/decrease the number of posts without giving any reason.

- xv. No TA/DA and accommodation shall be provided for attending Interview.
- xvi. Any corrigendum/addendum pertaining to this advertisement shall be published on the BSPCB website only. Applicants are advised to regularly visit the website www.bspcb.bihar.gov.in for updates.
- xvii. Candidates, who have obtained Degrees or Diplomas or Certificates for various courses from any Institution declared fake/de-recognized by the UGC/AICTE, shall not be eligible for being considered for recruitment to the posts advertised. If this is detected at any stage during their contract, their contract will be terminated forthwith.
- xviii. No interim correspondence whatsoever will be entertained from Applicants regarding conduct and result of interview and reasons for not being called for interview.
- xix. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the Competent Authority of BSPCB in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of interview will be final and no query or correspondence will be entertained in this connection from any applicant.
- xx. Candidate's admission to the Interview and subsequent process is strictly provisional. BSPCB would be free to reject any application, at any stage of the process, cancel the candidature of the candidate in case it is detected at any stage that a candidate does not fulfill the eligibility norms and/ or that he/she has furnished any incorrect/ false information/ certificate/ documents or has suppressed any material fact(s). If any of these shortcoming(s) is/are detected after appointment in BSPCB, their services are liable to be summarily terminated as per rules.
