**Proposed Direction under section 33A of the Water (Prevention and Control of Pollution) Act, 1974 and Section 31A of the Air (Prevention and Control of Pollution) Act, 1981.**

1. **WHEREAS**, the state Govt. had declared the entire State of Bihar as " Air Pollution Control Area" under the provisions 19 of the Air (Prevention and Control of Pollution) Act, 1981.
2. **WHEREAS**, you were required to obtain previous "Consent-to-Establish" (CTE) and "Consent-to-Operate" (CTO) of the State Board under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and under section 25 & 26 of the Water (Prevention and Control of Pollution) Act, 1974 before establishing and operating your industrial Plant.
3. **WHEREAS**, your unit was inspected on **07.12.2019** by the officials of the Board and during the said inspection it was observed that you are operating your **Maize Suji (Used for Raw Material of Kurkure) unit** without CTE and CTO of the Board which is flagrant violation of the provisions of the Water & Air Act.
4. **WHEREAS**, operation of your **Maize Suji (Used for Raw Material of Kurkure) unit** without CTE and CTO of the Board is illegal and also adversely affects the environment.

AND THEREFORE, taking into consideration all material facts including environmental concerns, in exercise of power vested under Section 33A of the Water (Prevention and Control of Pollution) Act, 1974 and 31 A of the Air (Prevention and Control of Pollution) Act, 1981 **it is proposed that your Maize Suji (Used for Raw Material of Kurkure) unit be closed down until CTE and CTO is obtained from the State Board, in accordance with law.**

You are hereby given an opportunity to file your objection, (if any), to the above proposed direction within 15 days from the receipt of this notice, failing which directions as proposed shall be confirmed against your **Maize Suji (Used for Raw Material of Kurkure) unit** without giving any further notice, in accordance with the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.
