Direction u/s 33A of the Water (Prevention and control of Pollution) Act, 1974 and under Section 31 A of the Air (Prevention and control of Pollution) Act, 1981.

1. WHEREAS, the State Government has declared the entire State of Bihar as "Air Pollution-Control-Area" under the provisions of Section 19 of the Air (Prevention and Control of Pollution) Act, 1981.
2. WHEREAS, you were required to obtain previous "Consent-to-Establish" (CTE) and "Consent-to-Operate" (CTO) under the provisions of Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and under section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974 before establishing and operating your industrial plant.
3. WHEREAS, you have obtained Emission Consent Order (CTO) and Discharge Consent Order (CTO) under the Air Act and the Water Act respectively, which are valid till 31.12.2023.
4. WHEREAS, your unit was inspected by the officials of the Board on 21.01.2019 and upon inspection, some observations were made and upon the observations so made, certain suggestions were recommended by the Inspecting Officers for mitigating the pollution being caused by your unit.

I, therefore, in exercise of the powers, conferred by section 33A of the Water (Prevention and Control of Pollution) Act, 1974 and section 31A of the Air (Prevention and Control of Pollution) Act, 1981, direct you as hereunder:

- (i) The unit shall get the bag filters checked immediately within 15 days from the receipt of this direction and file a compliance report: thereafter the bag fillers shall be checked every sixth month followed by a compliance report;
- (ii) The unit shall file a half yearly report specifically stating about the status of bag filters with all the relevant details as to when it was installed, last checked, etc.;
- (iii) The unit shall establish a wet scrubber between furnace and stack immediately, but not later than one month from the receipt of this direction; and
- (iv) Apart from the compliance report, as required above, a general compliance report with respect to all the directions, aforesaid, shall be filed within 30 days from the receipt of this direction.

In the event of failure to comply with the directions as aforesaid, Board will be constrained to file complaint under the appropriate provisions of the said Acts.


