Proposed Direction for Closure under Section 33A of the Water (Prevention and Control of Pollution) Act, 1974.

- 1) WHEREAS,** section 25/26 of the Water (Prevention and Control of Pollution) Act, 1974, restricts establishment or use of new or existing outlets or discharge without prior consent from the Board. In other words, persons are under obligation to apply for consent, before they take steps to establish any industry or are bringing into use any new outlet or are continuing with the existing Outlet for the discharge of sewage or trade effluent.
- 2) WHEREAS,** as per the guidelines issued by the CPCB vide letter no. B-4032/PCI-SSI/poultry2015 dated 20.10.2015, poultry farms with the capacity of less than one lakh birds per day, need not obtain CTO. However, they are required to comply with any criterion or guidelines laid down thereunder for the minimization of odour pollution, management of solid waste, management of waste water discharge and good housekeeping practices.
- 3) WHEREAS,** it may be worth mention here that this Board, issued Environmental Guidelines for Prevention and Control of Pollution in Poultry Units, which are to be complied with, by all poultry units, regardless of capacity.

- 4) **WHEREAS**, your unit was inspected on 07.03.2019, and it was found that Effluent Treatment Plant (ETP) was not installed for treatment of industrial effluent generated by your unit, and the untreated effluent was discharged into a nala. The solid waste generated by your unit was also not being disposed properly.
- 5) **WHEREAS**, in light of the above findings, a notice was served upon you by the Board vide letter no. 698 dated 12.03.2019, directing you to establish Biological Effluent Treatment Plant immediately and to submit an action plan for the same within 7 days from the receipt of the show-cause notice.
- 6) **WHEREAS**, you failed to file reply/action plan to the show-cause notice, so issued.
- 7) **WHEREAS**, operation of your unit , without an ETP is detrimental to environment as the untreated effluent is bound to cause water pollution. Further, the damage to the environment caused by you due to non-compliance of the guidelines of the Board in continuing operation of your unit without the necessary effluent treatment arrangements and consent of the Board warrants immediate action.

I, therefore, taking into consideration all material facts including environmental concerns, in exercise of the power conferred by Section 33A of the Water Act, 1974, **propose to close your unit**, and for the said reason, you are hereby given an opportunity to file your objection, if any, to the above proposed direction within 15 days from the receipt of this notice, failing which directions, as proposed above, shall be confirmed against your unit without giving any further notice, in accordance with the provisions of the Water (Prevention and Control of Pollution Act, 1974.
