**Direction for Closure under Section 31A of the Air (Prevention and Control of Pollution) Act, 1981.**

1. **WHEREAS**, the State Govt. has declared the entire State of Bihar as "Air-Pollution-Control-Area" under the provisions of section 19 of the Air (Prevention and Control of Pollution) Act, 1981 (hereinafter referred to as 'Air Act'), 1981.
2. **WHEREAS**, you were required to obtain previous "Consent-to-Establish" (CTE) and "Consent-to-Operate" (CTO) under the provisions of Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 before establishing and operating your industrial plant.
3. **WHEREAS**, all the brick kilns in the State of Bihar were directed to convert themselves from old technology to cleaner technology (modern technology) latest by 31.08.2019 and for which, wide publicity was given in the local newspapers to create awareness.
4. **WHEREAS**, the Hon'ble Patna High Court, Patna also, vide their order dated 04.12.2018, passed in CWJC No. 15962 of 2018, directed all the pre-existing units, uniformly without any distinction, to change to cleaner technology latest by 31.08.2019.

5. **WHEREAS**, it came to the knowledge of this Board that your Brick kiln was operational without converting it to the cleaner technology and that, too, without obtaining prior Consent -to-Establish (CTE) and Consent-to-Operate (CTO) from this Board.
6. **WHEREAS**, thereupon you were served with a Proposed Direction for Closure vide Board's letter no.1323, dated 25.02.2020 to which you failed to reply.
7. **WHEREAS**, further, an inspection of your unit was conducted on 28.05.2020, wherein it was found that your unit was still in operation without conforming to the aforesaid standards.
8. **WHEREAS**, from the aforesaid facts and findings, it is amply clear that you have come under operation in violation of the provisions of Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and also ignored the direction/observation of the Hon'ble Court, as you have not changed your brick kiln from old technology to the cleaner technology.
9. **WHEREAS**, in view of the already very poor air quality in Bihar, there is every likelihood that operation of your kiln will further aggravate the situation, causing grave injury to the environment, in general, and life around, in particular.
10. **WHEREAS**, your recalcitrant approach towards the mandatory compliance of law and defiance of the authority of the State Board, constituted under the Water (Prevention and Control of Pollution) Act, 1974, warrants stringent and deterrent action against you in favor of environmental protection.



I, therefore, in exercise of the powers, conferred by Section 31A of the Air (Prevention and Control of Pollution) Act, 1981, **direct you to:**

**stop and close all operations of your brick kiln with immediate effect.**

AND

in default thereof, the Board will be constrained to file complaint u/s 37 of the Air (Prevention and Control of Pollution) Act, 1981 with other actions under other suitable provisions of the Environment (Protection) Act, 1986.
