# Direction for Closure under Section 31A of the Air (Prevention and Control of Pollution) Act, 1981.

- 1. **WHEREAS,** the State Govt. has declared the entire State of Bihar as "Air-Pollution-Control-Area" under the provisions of section 19 of the Air (Prevention and Control of Pollution) Act, 1981 (hereinafter referred to as 'Air Act'), 1981.
- 2. **WHEREAS,** you were required to obtain previous "Consent-to-Establish" (CTE) and "Consent-to-Operate" (CTO) under the provisions of Section 21 of the Air (Prevention and Control and Pollution) Act, 1981 before establishing and operating your industrial plant.
- 3. **WHEREAS**, all the brick kilns in the State of Bihar were directed to convert themselves from old technology to cleaner technology (modern technology) latest by 31.08.2019 and for which, wide publicity was given in the local newspapers to create awareness.
- 4. **WHEREAS,** Hon'ble Patna High Court, Patna also, vide their order dated 04.12.2018, passed in CWJC No. 15962 of 2018, directed all the pre-existing units, uniformally without any distinction, to change to cleaner technology latest by 31.08.2019. To make the things more clear and emphatic, the

Hon'ble Court made it clear that such time was more than sufficient and was basically in public interest and for safeguarding further pollution to the atmosphere. The Hon'ble Court also recorded the findings that petitioners (brick kiln owners) had specifically undertaken that they would shift to cleaner technology latest by 31.08.2019.

- 5. **WHEREAS,** after lapse of the stipulated period of 31.08.2019, an inspection was conducted by the Board on 13.05.2020 and it was found that work of moulding was going on and firing was expected and that, too, without obtaining prior Consent –to-Establish (CTE) and Consent-to-Operate (CTO) from this Board.
- 6. **WHEREAS,** from the aforesaid facts and findings, it is amply clear that you have come under operation in violation of the provisions of Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and also ignored the direction/observation of the Hon'ble Court, as you have not changed your brick kiln from old technology to the cleaner technology.
- 7. WHEREAS, in view of the already very poor air quality situation in and around Sheikhpura, there is every likelihood that firing of your kiln will further aggravate the situation, causing grave injury to the environment, in general, and life around, in particular, and as such it is not expedient to provide you an opportunity to file objection/ objections against the Proposed Direction (show cause), which the Board, otherwise, would have issued.
- 8. **WHEREAS**, your recalcitrant approach towards the mandatory compliance of law and defiance of the authority of the State Board, constituted under the Water (Prevention and Control of Pollution) Act, 1974, warrants stringent and deterrent action against you in favor of environmental protection.

I, therefore, in exercise of the powers, conferred by Section 31A of the Air (Prevention and Control of Pollution) Act, 1981, direct you to:

stop and close all operations of your brick kiln with immediate effect.

### AND

in default thereof, the Board will be constrained to file complaint u/s 37 of the Air (Prevention and Control of Pollution) Act, 1981 with other actions under other suitable provisions of the Environment (Protection) Act, 1986.
