In compliance and implementation U/S 17 & 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 and U/S 17 & 21 of the Air (Prevention & Control of Pollution) Act, 1981 and notifications issued previously vide Ref.No:26 dated: 08.11.2003, Ref.No: 03 dated: 21.01.2004, Ref. No: 10 Dated: 03.08.2007, Ref. No: P/T.Vi.-4/2000-03 dated: 26.03.2009 and Ref. No: P/T-4/2000 – 104 dated: 09.08.2015, the guideline is hereby extended & amended for establishment of Brick Kiln unit as here under:-

2. **“Consent to operate”** shall be allowed only for Brick Kiln units **constructed under Cleaner Technology**
3. Name & Address of unit/Proprietor/Marka of Bricks manufacturing/Details of site shall be displayed on the stack of brick kiln.
4. Port hole, platform & ladder/provision for sampling shall be provided in the stack to monitor stack emission.
5. The approach road & road all around the kiln shall be made by brick paving or of concrete & water spraying arrangement shall be developed to minimise dust emission during transportation.
6. Tree plantation shall be developed all around the campus of the unit and shall be maintained.


