

Minutes of Public Hearing for proposed development of 4 lane inter corridor (Green Field Alignment) from Shivrampur to Ramnagar under Bharatmala Project. This proposed highway starts from village 'Berthu, P.S.-Karai Parsurai', Distt.-Nalanda to Village-Kanhauli, P.S.-Karai Parsurai, Distt.-Nalanda in the State of Bihar.

VENUE: Play Ground of Uchha Madhymic Vidyalay, Berthu, Anchal-Karai Parsurai, District-Nalanda.

Date & Time: 29th Dec, 2021; At: 12.30 P.M.

Number of persons participated in the Public Hearing were 29 and their list is enclosed as Annexure-I.

Sri Naushad Ahmad, ADM, Nalanda welcome the representatives of the project proponent, public and other participants present during the public hearing. He initiated with introduction about the project and given a brief introduction about the project. Explained about how the area of the proposed project will be developed with increase in land value. Dr. Vinay Yadav, EIA Consultant of the project explained the project details and highlighted the following:-

- Described about the project salient features, baseline environmental data & conditions. The proposed highway starts from village-Shivrampur located at the District boundary of Gaya-Jehanabad and ends at Village-Ramnagar which is connecting the SH-78 road and passing through districts Jehanabad, Patna & Nalanda in the state of Bihar. The total length of the project is 54.325 km out of which 2.86 km is passing through the district of Nalanda. The proposed project highway is passing through four villages-Berthu, Abupur, Salempur & Kanhauli in the district of Nalanda.
- The total land requirement is 341.66 ha. Out of which 15.9754 ha. Will be acquired in Nalanda District. The propose ROW is 60 meters. The propose highway will connect north

Bihar to south Bihar and to give connectivity to remote areas in major cities. For better connectivity and movement of local traffic in the project area appropriate number of structures (major bridges-3, minor bridges-44, vehicular underpasses-4, LVUP-3, SVUP-2, Interchanges/fly overs-2, ROB-1, Box Culverts-88) will be constructed. Cross drainage structures (Bridges & Culverts) at appropriate locations will be constructed for free flow of water during rainy season.

Response of the Public & their opinion:

In the public hearing following persons have expressed their views/opinions as given below:

1. **Sri Sanjay Ram, S/o-Sri Chandra Siva Ram, Village-Mehdichak & Sri Vinod Singh, S/o-Sri Vishwa Mohan Singh, Village-Jein Chak of P.S.-Karai Parsurai:** Asked about connectivity of highway to local roads.
2. **Sri Rajendra Paswan, Village-Baripur, Karai Parsurai:** He said about water logging near his village area.

Reply of project representative:- Stated that connectivity shall be provided at appropriate locations along the proposed highway. For better connectivity in the project area appropriate number of structures: vehicular underpasses, LVUP, SVUP & Box Culverts will be constructed.

Lastly, ADM, Nalanda Stated that priority shall be given to villagers of the area in reference to their safety, local connectivity and other amenities under the Rules.

Conclusion:

Overall views of the public participated in the hearing were in favor of the project. The public hearing has been conducted successfully.

The proceedings of the public hearing are recorded and video taken. The same shall be submitted to all concern and the authority for necessary action.


